#### **Practical Session**

Practical shall verify that the delegate is able to complete the following:

- Don the appropriate PPE (PFD, hard hat, gloves, closed-toe shoes) in a safe area.
- Inspect a rigid Personnel Basket.
- Inspect a collapsible Personnel Basket
- Correctly board the collapsible personnel basket and stand in the appropriate location, evenly distributing weight, if applicable.
- Arrange body to prepare for lift: Use both hands to grasp the Personnel Basket and keep knees bent.
- Demonstrate proper stance and behavior during the transfer.
- Demonstrate proper disembarkation procedures, bending knees during the landing and moving away from the Personnel Basket when it is safe to do so.
