CA-EBS Initial Deployment Training

Course Aim and Target Group – This program is designed for personnel that are issued with Compressed Air Emergency Breathing System (CA-EBS) whilst travelling to work by helicopter and may be required to use a CA-EBS in the event of an emergency.

Course Outcomes

Compressed Air Emergency Breathing System (CA-EBS) Initial Deployment Training

The learner will understand:

- 1. The rationale and use of compressed air emergency breathing systems in helicopter emergency situations, Including the fundamental differences between re-breather and compressed air systems (technology and use)
- 2. The hazards associated with compressed air emergency breathing systems

The learner will perform:

- 3. Use of the Compressed Air Emergency Breathing System (CA-EBS)
 - 1. A pre-flight inspection of the life jacket and compressed air EBS
 - 2. Donning a life jacket complete with compressed air EBS correctly, including 'buddy check'
 - 3. Carrying out an emergency deployment of the CA-EBS in a dry environment

Physical / Health Demands:

Emergency response training contains physically demanding and potentially stressful elements. All personnel who participate in such training must be medically fit and capable of participating fully. All personnel will be required to complete a self-declaration of fitness form prior to commencement of practical.

Start / Finish Times:

Training courses will begin at 7:30 am and should conclude by 8:30 am; it is recommended that delegates arrive at 7:00 am.

Equipment Requirements:

Delegates are expected to provide the following items during training:

• Government Issued Photo Identification – Required

Meals / Refreshments:

Delegates will be provided with a 1-hour lunch (if applicable) break with meals provided at client's expense. Coffee and water will be available free of charge. Periodic breaks will be offered to delegate's during training.
